Chairman Ruecker called the meeting to order at 7:31 PM.

1. <u>SPECIAL MEETING</u>

a) <u>Discuss Logos on Service Authority Water Storage Tanks</u>

Mr. Dickey advised Board Members that Supervisor Anderson directed Prince William County (PWC) staff to work with Authority staff to develop a Memorandum of Understanding (MOU) to put the County's wordmark on the Authority's tanks that are currently being rehabilitated and/or are scheduled for rehabilitation soon. Mr. Dickey requested the Board's comments and direction on putting the County's wordmark on the Gainesville water storage tank. He advised a decision about which logo to paint on the Gainesville water storage tank needs to be made tonight in order to keep the rehabilitation project on schedule (the contractor has to be notified by Friday, August 10, 2018).

Mr. Dickey reported that he and Service Authority staff are meeting with PWC representatives on Wednesday, August 15 to begin discussions on writing an MOU between both parties to provide specific guidance on painting logos on tanks that will be rehabilitated in the future, as well as any new tanks the Service Authority builds.

Mr. Dickey noted there is more time to make a logo decision on the Airport tank should that request come from the County.

In response to a question, Mr. Dickey advised it will cost \$8,000 to paint a logo on the Gainesville tank now, while the crew is mobilized; this cost is already included in the bid. If staff delays the decision to a later date, and the crew has to be called back, the cost to paint the logo on the tank would be approximately \$27,000.

2. <u>ACTION MATTER</u>

a) Approval of Prince William County Wordmark on Gainesville Water Storage Tank

Chairman Ruecker called for a motion for the referenced Resolution.
