Questions and Responses

1. Question: Is lockbox out of scope for this RFP?

Response: Lockbox is not within the Scope of Work for Required Services in this RFP. The Service Authority is currently under contract with a third party for our lockbox services. However, we are open to receiving information about lockbox services that a bank may offer as a part of this RFP process.

2. Question: Who is your current e-lockbox provider?

Response: The Service Authority currently accepts payment for online bill pay from CheckFree and Online Resources. The process is currently manual with a daily file received for payment in the bank and a separate report via email providing the customer account details to manually process within the Authority's system. Through this RFP, the Service Authority is interested in exploring options to receive a consolidated file to post to the backend system for automated processing.

3. Question: Regarding P-cards, how many cards do you estimate you will need?

Response: We currently have around 30 credit cards issued to users and would expect a similar number for P-cards.

4. Question: Regarding P-cards, what is the estimated annual spend?

Response: The estimated annual spend, were the Service Authority to migrate from Credit Cards to a P-card program, would be approximately \$600,000 - \$700,000 annually, assuming spending would remain at current levels on our credit cards.

5. Question: Regarding P-cards, can you provide a vendor list for the last 12 months? By viewing the vendors and dollar amounts you spend, this will allow us to do a side by side comparison to see who is currently accepting Virtual Card and what your potential rebates could be.

Response: See Attachment B – Vendor Payments.

6. Question: Are you currently utilizing an armored courier?

Response: Yes, the Service Authority contracts separately with an armored courier service.



7. Question: Regarding lockbox services, on the pricing sheet there is only 1 line item for the checks deposited at Deluxe. Can you please provide the detailed line item information that would include the volume and service description?

Response: This information is not available.

8. Question: Regarding lockbox services, is your lockbox retail or wholesale?

Response: Retail

9. Question: Regarding lockbox services, does it have any seasonality that would result in significant balance changes?

Response: No

10. Question: Regarding lockbox services, what type of payments do you receive other than check? i.e. cash, card.

Response: Payments received are almost exclusively by check. Our servicer will accommodate processing a remittance received with cash, but there is an additional per-payment fee. Card payment is not accepted through lockbox.

11. Question: Regarding lockbox services, does your lockbox utilize any of these additional services? Positive file, lookup file, cross reference file, MICR matching, card or virtual card transactions, web exceptions, online archive, stop file, data file, image file, AR file.

Response: PWCSA has access to, but generally does not utilize the majority of these additional services, at least not with any regularity, with the exception of the online archive.

12. Question: For the fee schedule provided in the PDF. Is there any way we could receive that in excel format so we can add additional information and lines into the spreadsheet?
