a) <u>Approval of Fiscal Year 2021 Operating and Capital Budget and FY2021-FY2025 Capital Improvement Program.</u>

Mr. Dickey advised the budget presented has a 0.3% negative budget variance and is responsive to the COVID-19 emergency and the impact on our customers. Staff hope to return to the Board later in the year to eliminate or reduce the next rate increase. The budget includes a 7.1% decrease in personnel; no raises or one-time payments for staff; a reduction in the Virginia Retirement System (VRS) employer contribution; and a planned debt issuance for critical capital projects. Mr. Dickey asked the Board Members to approve the resolution.
