2. PRESENTATION

a) <u>Presentation</u>: Chairman's Gavel Plaque to Dr. Kooyoomjian

Chairman O'Meara presented the Chairman's Gavel Plaque to Dr. Kooyoomjian in recognition of his service as Chairman of the Prince William County Service Authority (Service Authority) Board of Directors from 2019-2021. Board Members shared comments and congratulations; Dr. Kooyoomjian thanked Board Members and staff for their support.

4. GENERAL MANAGER'S REPORT

- a) Mr. Farr advised Board Members if they are interested in touring the H.L. Mooney Advanced Water Reclamation Facility this fall to please contact Ms. Murray. Staff will offer additional tours in the spring.
- b) Mr. Farr reported that UOSA (Upper Occoquan Service Authority) staff is offering plant tours to its own Board Members this month. They have a few spots available for the Service Authority's Board Members on the Wednesday, October 27 tour (at 1 PM); if Service Authority Board Members are interested they should contact Ms. Murray as soon as possible. Mr. Farr noted he is attending the October 27 tour.
- c) COVID-19 Update: Mr. Farr advised that staff continues to follow COVID-19 safety protocols; there have been very few COVID cases among staff. The executive team is closely monitoring the possibility of a federal vaccination mandate, although nothing has been presented yet. Mr. Farr offered to keep Board Members updated as more information is available.
- d) Collections Update: Mr. Farr provided the status of the number of customer payment plans and shared that the Service Authority has applied for utility assistance funds for customers. He noted the Service Authority wants to do everything possible to assist customers and avoid service disconnections. Discussion was held.

6. ADMINISTRATIVE REPORTS

The Chairman asked if any Board Members had questions on the Capital Improvement Program (CIP) Status Report or the H.L. Mooney Advanced Water Reclamation Facility Operating Results report. There were no questions on those two reports.

Mr. Akinkugbe provided a brief presentation on the August Monthly Financial and Operational Report. Discussion was held. Mr. Wiggins asked about non-compete agreements. Mr. Farr stated staff would look at this in more detail. Mrs. Nelson responded to questions about collections. She shared that write-offs and liens remain suspended at this time. Staff expects to receive notification of the award of assistance funds in the next four weeks. The certification and receipt of funds is coordinated through Prince William County (PWC). Discussion held regarding the projection of capital spending and delinquent accounts. Staff will consider presentation options for future monthly reports.

7. CONSIDERATION OF MATTERS PRESENTED BY MEMBERS

Dr. Kooyoomjian enjoyed reading the FY2021 Business Accomplishments report. He also referenced a water-related article in the October 2021 issue of *Rotary* Magazine and asked Ms. Murray to share the article with Board Members. Dr. Kooyoomjian expressed his appreciation in serving as chairman of the Board of Directors for two years.

Mr. Wiggins noted the Prince William Board of County Supervisors has discussed the need for affordable housing in the county. He asked if the Service Authority can lower the connection fees for moderate- and low-income housing. Chairman O'Meara stated staff will look at this and report back at the next meeting. Mr. Viani advised there is typically no discount for water and sewer connections, as they are secured with bonds.

Mr. Almond commended staff on their knowledge about current issues. He also thanked Dr. Kooyoomjian for his leadership as chairman.

Mr. Colangelo thanked Dr. Kooyoomjian and staff for leading the organization during the pandemic. He added he is very impressed with the leadership at the Service Authority.

Mr. Dickey thanked and congratulated Dr. Kooyoomjian and echoed the others' comments about his service as chairman. He also thanked leadership and staff for the outstanding job they all do for the citizens of PWC.

Chairman O'Meara announced the November Board meeting agenda will include a consent agenda. He advised that he appointed Mr. Wiggins to serve as the fourth member of the Audit Committee. Mr. O'Meara also thanked Mr. Farr and his team for assisting him in preparing for his first meeting as chairman.
