- 7. Question: Page 40 says SA expects to award contracts in 2 phases. Will the same team be selected now for both phases? Can you confirm teams should submit for both Phase 1 and Phase 2?

  Response: Yes. The same team will be selected for both phases. The Offeror shall submit a proposal for both phases I and II.
- **8. Question:** Per page 40 in the solicitation, are you giving priority to PWC based firms? **Response:** The language on page 40 of the solicitation is intended to communicate that the Service Authority values project experience in Prince William County. However, this does not preclude firms that have appropriate design and construction experience outside of Prince William County.
